A pet puppy is defined here to be a Siberian Husky puppy which is in good health at the time of sale, and embodies the characteristics of the Siberian Husky breed . This puppy is purebred and is registerable (registered) with the American Canine Association and/or America's Pet Registry Inc. and/or the United Kennel Club

The parents of this puppy are CERF (eyes) and PennHIP (hips) certified, with results of 'good' or better.

This puppy is registered with a limited registration, which will prohibit breeding and registering offspring. ((Buyer's name) agrees this puppy is to be spayed/neutered at the appropriate age, and veterinarian confirmation of this procedure must be supplied to Crimson Creek Kennels within a period of 90 days after said procedure.)

Crimson Creek Kennels guarantees the above described dog to be healthy at the time of the sale.

Crimson Creek Kennels does not assume any liability for any injury to said puppy after delivery.

(Buyer's Name) agrees to have this puppy examined by a veterinarian within 72 hours of delivery to verify health or all guarantees are void.

If the puppy is found to be other than healthy by the buyer's veterinarian, it shall be returned to Crimson Creek Kennels immediately, and the purchase price will be refunded. Deadline for this refund is (Date).

Crimson Creek Kennels offers a two year health guarantee of any genetic disease found to be inherited from said puppy's ancestors.

All appropriate shots for the puppy's age have been given, and a record of this vaccination history is supplied to the buyer at time of purchase.

(Buyer's name) agrees to maintain the puppy's health in good condition, and to provide yearly examinations, vaccinations, heartworm test, and any other usual procedures necessary to assure good health.

Crimson Creek Kennels has done everything possible to produce healthy sound puppies both by breeding only dogs that are certified free of hip and eye disorders appropriate of the breed, and by raising the puppies in the best way possible in regards to diet, exercise, socialization and veterinary care.

There are many factors that can influence growth and development, such as diet, exercise, weight gain, etc.. (Buyer's name) assumes the responsibility to carry on with the appropriate vaccinations, exercise and feeding schedule, as supplied by Crimson Creek Kennels. MOST PARTICULARLY, (buyer's name) agrees to keep the puppy slim throughout it's normal growth period. Crimson Creek Kennels can offer no further guarantees once the care of the puppy is no longer under their control.

(Buyer's name) agrees that neither he/she nor their estate/executors will sell this puppy or transfer ownership of this puppy without the Crimson Creek Kennel's knowledge and written consent

(Buyer's name) hereby agrees that if at any time they cannot take proper care of the puppy, they must contact Crimson Creek Kennels and they will have the first choice to either: (a) take said puppy back or (b) assist the buyer in finding a suitable home for the puppy.
